CONDITIONS

STUD OWNER AGREES TO:

- 1. Provide the female's owner with a pedigree of the dog.
- **2**. Have the stud dog in good physical condition.
- 3. Sign litter registration promptly and return to the female's owner.
- **4.** Provide a return stud service to the same female owner if less than 2 or no puppies are produced from the mating, at no charge with provided documents for proof of all fertility steps taken. If the stud is no longer available for whatever reason, for the return service, the stud owner reserves the right to offer a different stud to the female owner.

FEMALE'S OWNER AGREES TO:

- 1. Pay the agreed stud service fee before the female is serviced.

- 2. Unless for a puppy back deal, Which will be picked up on or shortly after 8 weeks of age. Registry papers will not be signed until the stud owner receives the puppy from the female's owner.
- a.puppy back deal consists of

3. Keeping the female in good health and in season.

- **4.** If stud and female do not mate naturally, the female must be artificially inseminated at the female's owner's expense.
- **5.** Must follow all fertility procedures which may include but not limited to vaginal cytology, progesterone, transcervical insemination, surgical insemination, ultrasound, X-ray, c-section, vet check of female and puppies before and after whelp. Failure to provide proof of such services rendered to the female during and after whelp can void this contract for future repeat.
- **6.** Any disputes arising out of or in connection with this contract shall be settled through arbitration in accordance with the rules of the LA Superior Court, West Covina.
- 7. The Female owner must notify the stud owner of the first signs of heat. Three days may not lapse at the first signs of heat or swelling of the vulva. These requirements must be met for the stud owner to make arrangements and be prepared for breeding.
- **8.** The Female owner agrees to take pictures and live video of the female during the window day 50-60. The Female owner will also need to take pictures and live video of the litter on the day the litter is born and two weeks after for registration. The Stud owner will not approve AKC

litter confirmation until puppies are 2 weeks old and out of the danger zone.

9. Stud expiration is 3 years from the date of the contract.

OTHER CONDITIONS

- 1. TWO PUPPIES CONSTITUTE A LITTER. STUD OWNER WILL REPEAT BREEDING IF PUPPIES ARE STILL BORN AND FEMALE OWNER PROVIDES ALL RELATED VET DOCUMENTS TO STUD OWNER TO PROVE EVERY STEP WAS TAKEN TO ENSURE THEY WOULD BE BORN ALIVE. NEGLIGENCE WILL VOID THE CONTRACT IF ALL PROPER STEPS ARE NOT TAKEN WITHIN A TIMELY MANNER
- **2.** ALL FEES ASSOCIATED WITH TRANSFER OF SEMEN, STUD, ARTIFICIAL INSEMINATION. ARE TO BE PAID BY FEMALE'S OWNER.
- **3**. IF THE FEMALE FAILS TO CONCEIVE OR PRODUCE A LITTER ON THE RETURN SERVICE, THIS CONTRACT IS TERMINATED.
- 4. ALL FEES PAID TO STUD OWNER(S) ARE NON-REFUNDABLE.
- **5.** IF THE STUD IS NO LONGER AVAILABLE AT TIME OF BREEDING FROZEN SEMEN CAN BE USED, OR THE STUD CREDIT CAN BE USED TOWARD ANOTHER STUD IN THE CAMP
- **6.** STUD OWNER RESERVES THE RIGHT TO REFUSE STUD SERVICE TO THE NAMED FEMALE IF ALL REQUIREMENTS ARE NOT MET.
- 7. ALL CREDIT CARD TRANSACTIONS INCLUDE A 3.5% PROCESSING FEE. BY INITIATING AN ELECTRONIC PAYMENT, THE CUSTOMER ACKNOWLEDGES AND AUTHORIZES THE PAYMENT, UNDERSTANDING THAT IT IS FINAL AND IRREVOCABLE. THE CUSTOMER FURTHER AGREES NOT TO DISPUTE ANY VALID CHARGES PROCESSED THROUGH THE AUTHORIZED PAYMENT METHOD.
