**1. Health Guarantee-** This dog is guaranteed, to the original purchaser, to be free of disease or defect that occurred from the genetics of the dog for the following period of time 1 YEAR if during this time the dog is found to be defective a replacement by one of equal value and gender will be permitted. In returning this dog, there will be a required Pet Wellness Report Card/Examination record from the Licensed Veterinarian stating the breed, age, history of care, and diagnosis. Upon this proof, there will be an additional opportunity to have the dog examined by a veterinarian of the seller's choosing. If a dispute arises after examination from the seller's chosen veterinarian, both buyer and seller will have the opportunity to mutually choose a third-party veterinarian and be present upon examination to help resolve said dispute. Initial transport of this dog back to the seller will be at the cost of the buyer.

**3. The new owner will retain the responsibility of completing all necessary registration information and must include the word/s**

**4. This dog must be examined within three days of delivery to the buyer by a licensed veterinarian, or the health guarantee is void. A copy of the Pet Wellness Report Card/Examination certificate must be provided and emailed to 24kfrenchiesla@gmail.com within 24 hrs of exam. Exchange or refund will not be required due to sustained injury, environmental health exposure leading to illness, neglect/abuse, or common health or skin conditions; if returned upon examination, the seller has the right to maintain this dog in quarantine at the expense of the buyer for a period of two weeks with any associated costs being deducted from the original purchase price.**

**5. Adequate and responsible confinement will be provided by the buyer to prevent escape, harassment, or possible injury to the dog and (or) the public in order to assist in the positive promotion of the dog breed and its responsible ownership.**

**6. Buyer agrees to provide adequate food, water, shelter, exercise, health care, and socialization. Enrollment in**

obedience training has been recommended to help the buyer understand effective means of communicating with this dog. Participation in microchipping has been encouraged to help insure a return to the owner in the event that this dog becomes lost or stolen.

7. Buyer agrees to first consult the seller in the event that the purchaser cannot keep the dog before selling it or taking it to a shelter, pound, rescue, or any other animal welfare organization for turn-in with the understanding that such a return does not constitute refund in whole or part. If the seller is unable to accept the dog the owner will do their best to rehome the dog with a new, responsible owner before opting to turn this dog into any shelter, pound, rescue or animal welfare organization. If such a home is unable to be found in a reasonable period of time the owner will do their best to locate a no-kill rescue or shelter who can accept this dog.

8. Buyer has been made aware of almost certain euthanasia of this dog if it is turned into a shelter, rescue, or other animal welfare organization and of the unfriendly nature many such organizations have in regards to this breed.

9. All credit card transactions include a 3.5% processing fee. By initiating an electronic payment, the Customer acknowledges and authorizes the payment, understanding that it is final and irrevocable. The Customer further agrees not to dispute any valid charges processed through the authorized payment method.

10. All deposits are non refundable but are transferable to another litter, puppy, or an adult dog from the seller.

11. In the event of any disputes, jurisdiction will be exclusively in the LA Superior Court located in West Covina, CA.
