1. The Purchaser hereby acknowledges and understands that the purchased dog is explicitly designated as a pet and will be placed in a Pet Home, without any AKC (American Kennel Club) or other registry paperwork. The Purchaser solemnly commits to providing a loving, safe, and responsible home for the dog. This contract is subject to the laws of the state or jurisdiction where the Seller is situated, specifically LA Superior Court in West Covina, CA. It constitutes a comprehensive agreement between the parties concerning the pet's status and the absence of paperwork, and any modifications to this agreement require written consent from both parties.

2. Adequate and responsible confinement will be provided by the buyer to prevent escape, harassment, or possible injury to the dog and (or) the public in order to assist in the positive promotion of the dog breed and its responsible ownership.

3. Buyer agrees to provide adequate food, water, shelter, exercise, health care, and socialization. Enrollment in obedience training has been recommended to help the buyer understand effective means of communicating with this dog. Participation in microchipping has been encouraged to help ensure a return to the owner in the event that this dog becomes lost or stolen.

4. Buyer agrees to first consult the seller in the event that the purchaser cannot keep the dog before selling it or taking it to a shelter, pound, rescue, or any other animal welfare organization for turn-in with the understanding that such a return does not constitute refund in whole or part. If the seller is unable to accept the dog, the owner will do their best to rehome the dog with a new, responsible owner before opting to turn this dog into any shelter, pound, rescue, or animal welfare organization. If such a home is unable to be found in a reasonable period of time, the owner will do their best to locate a no-kill rescue or shelter that can accept this dog.

5. In the interest of bettering the dog breed, the owner will notify sellers of life-threatening or disabling diseases or defects during its lifetime. Such diseases or defects include but are not limited to cancer, hip elbow or other orthopedic issues, heart or other internal organ conditions, cataracts, infertility, birthing difficulty, offspring with birth defects, mental disorders, etc.

6. The Purchaser agrees to spay/neuter the dog within one year from the signing of this contract. A copy of the spay/neuter certificate performed by a licensed vet must be provided via email at <u>24kfrenchiesla@gmail.com</u>.
